

## **ORDER**

(FILED - May 22, 2014)

Pursuant to the Order Establishing District of Columbia Access to Justice Commission, filed December 29, 2004 (No. M-220-04), and the order dated October 9, 2007, continuing the District of Columbia Access to Justice Commission, it is

ORDERED that the Commission shall be expanded to 21 members appointed by this court as follows:

- Four (4) judges nominated by the Joint Committee on Judicial Administration in the District of Columbia;
  - Two (2) persons nominated by the District of Columbia Bar;
  - Two (2) persons nominated by the District of Columbia Bar Foundation; and
- Four (4) persons nominated by the Consortium of Legal Service Providers, at least one of whom shall be a leader of a community-based organization serving persons living in poverty or a client of a D.C. legal services provider.

The remaining nine (9) members shall be selected on the basis of a demonstrated commitment to, and familiarity with access to justice issues.
