

FY25 BY THE NUMBERS


- FY24 Total = \$31,667,840
- Budget Request = \$31.7M
- Mayor Proposed = \$10.457M
- Judiciary Committee Enhancement = \$2.2M
- COW Enhancement = \$19M
- FY25 Total = \$31,667,840

- Performance Oversight = 19 witnesses
- Budget Oversight = 51 witnesses




LOOK BACK AT FY25 ADVOCACY

FY26 BUDGET OUTLOOK JON BOUKER

FORMULATING FY26 BUDGET REQUEST

- Commission annually approves and submits in consultation with DC Bar Foundation
- Typically seek level or increased funding
- Includes breakdown of funding request, per program (ATJ, CLCPP, LRAP)
- Provides examples of funded work (i.e., family, consumer, housing, etc.)
- Use letter as opportunity to capture the impact of the programs
- Includes snapshot of community needs, changes

DISCUSSION

- What are the greatest areas of community need? Are these new or different?
- What do you anticipate in FY26?
- What is unknown?
- Other system needs to consider (i.e., CIR, Self-Help)?
- Do you have good data, anecdotes, etc. for us to highlight to demonstrate impact?

- Other feedback on the budget letter?
